Youth Rates (per person) - Minimum age 10, through age 18 (Other ages by approval only).

Adult Rates (per person) - Ages 18 and up.

Group Discount

- **Groups with 30 or more participants will receive an additional 5% off if all forms are received 5 business days before the program.**

NOTES:

- **Specialty programs may be coordinated at a different rate, based on program type, length, content, and group size.** Information and group size will be communicated and determined in program contract.
- **A non-refundable deposit of \$50.00, or approved purchase order, will be required to reserve a program date.**
- Reservation requests are required at least 2 weeks prior to desired program date(s). Early reservations recommended.
- Payment is due before the start of the program, or may be invoiced with approval of the Program Director.
- Cost does not include meals, however meals can be provided at an additional cost.
- Minimum number of billed participants per group is 10. Maximum group size varies on program type, content, etc.

CANCELLATION POLICIES:

- All groups are scheduled for Outdoor Education Programs by a program contract with ICPRD. Information contained within this contract identifies all details and requirements. This is our guide and is designed to help us deliver the best possible experience.
- Any changes within the contract must have prior approval of the Course Director. Breach of contract and/or non-compliance with standards will result in a cancellation. Groups will receive no refund of deposits and the organization will be billed for the minimum group size.
- **Cancellations must be received at least 2 weeks in advance of your scheduled program, otherwise the organization will be charged for the minimum group size. No refunds of deposits will be given.**
- **Weather:** With light rain or possible showers, we may continue with the scheduled program. For other conditions (heavy rain/storms, high winds, dangerous traveling conditions, temps below 32° or above 96°), the program can be rescheduled. The lead facilitator will discuss options with the group contact person as needed.
