The following answers questions and clarifies information contained within the original bidding document released to bidders. Failure to consider all information contained within this addendum does not relieve vendor from any responsibility to perform the project for the bid price offered. This Addendum consists of one page.

GENERAL INFORMATION:

1. Surgical masks: Must be Medical, ASTM Level 1. They will be used by medical professionals and frontline workers.
2. Isolation gowns: AAMI Level 3 is preferred and will be primary focus for award. However, we will consider level 2 and level 1.
3. Face Shield: Must be one size fits all, infectious disease control shield (spit shield), complete face shield assembly with elastic attachment and foam forehead cushion so each unit can be disposed of after use at minimal expense. Should include a re-sealable bag to keep the unused product clean and ready for use. Individual units should be able to be rolled into a tube and stowed in a cargo pocket for easy access when needed.
4. PPE Kit Contents, should include: (1) Biohazard Bag, Red, 10 Gallon; (1) Face Mask with Ear Loops, Disposable; (1) Isolation Gown - Full Back, Knit Cuffs, Tie Waist; (1) Pair Gloves, Large
5. Can the manufacturer/supplier be located in CA? Yes.
6. Due to federally imposed time limits related to the delivery of purchases made using CARES Act funds, Iredell County reserves the right to review all products offered through this solicitation, and vendor information, and to accept or reject any bid or offer that, in its sole determination, may not provide for delivery and easy/quick correction of incorrect, damaged, or substandard supplies or shipments.
